

NOTICE OF MEETING

FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 24

The Board of Directors of Fort Bend County Municipal Utility District No. 24 will hold a regular meeting on **Thursday, January 8, 2026, at 10:00 a.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, **on the First Floor, in the Executive Conference Room**, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Approve minutes.

5. Maintenance of District drainage facilities, including proposals for work.
6. Annual report regarding Post-Issuance Compliance Policy.
7. Financial and bookkeeping matters, including:

10. Fort Bend Subsidence District matters.
11. Operation of District facilities, including billings, repairs and maintenance, customer correspondence, and message language on water bills.
12. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
13. Engineering and park construction matters, including:
 - a. design, plan approval, advertisement for bids and contract award, approval of pay estimates and change orders, final acceptance, and materials and field testing, including:
 - i. Olympia Fields Section 2;
 - ii. Olympia Fields Section 3;
 - iii. Olympia Fields Section 4;
 - iv. Olympia Fields Lift Station;
 - v. Olympia Fields Phase 2 Detention and Drainage;
 - vi. facilities to serve the annexation tracts, including:
 - aa. Wastewater Treatment Plant Phase I, including updates on construction and contractor reimbursement of certain expenses and interest on retainage;

- bb. construction of new water plant;
- cc. Wastewater Treatment Plant Phase II; and
- vii. Sidewalk Improvements Phase 2;
- b. update on amending the District's Park Plan;
- c. water reuse study;
- d. deeds, easements, plats and consents to encroachment;
- e. requests for service or utility commitment letters;
- f. update on bond application no. 9; and
- g. installation of street lights on Lake Olympia Parkway and Chimney Rock Road.

14. Park and recreational facilities matters, including:

21. Reconvene in Open Session and authorize appropriate action regarding pending or contemplated litigation, or a settlement offer.


